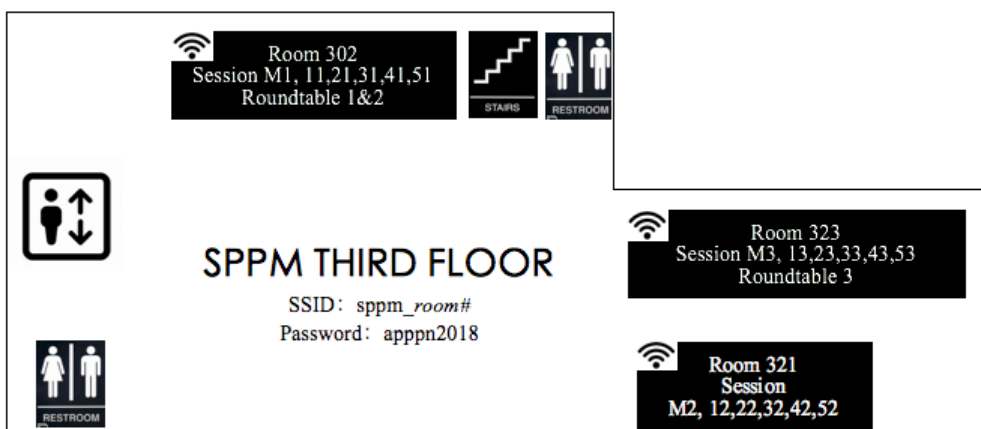
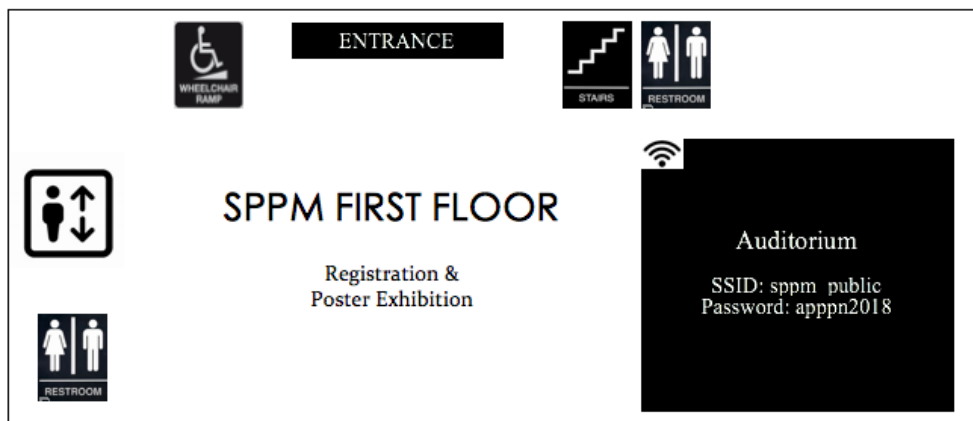

## Keynote Speakers



**Prof. Iris Geva-May** is Professor Emerita at Simon Fraser University and currently Honorary Professor at Carleton University and Wagner University. She is also the Founding President of the International Comparative Policy Analysis Forum and the Founding Editor-in-Chief of the *Journal of Comparative Policy Analysis*. She was visiting professor and taught in many countries around the globe.

Her expertise includes Comparative Public Policy and Policy Program Development. Among others her books are *An Operational Approach to Policy Analysis*, *A Clinical Approach to Policy Analysis*, *A Methodology for Policy Analysis* (forthcoming), and co-edited *Routledge Handbook of Comparative Policy Analysis*, *International Library for Policy Analysis*, and *the Classics of Comparative Policy Analysis*.



**Prof. Zhiyong Lan** is now professor at School of Public Policy & Management at Tsinghua University. He is an Expert of Thousand-Talents Program of China. Before moving to China, he is full professor at Arizona State University.

He has studied and researched areas of general public administration theory, government institution reform, public policy, conflict management, urban management innovation and sustainable development for almost 20 years.

He won a number of research and service awards, and serves on editorial boards of a number of journals including *Public Administration Review*, and *American Review of Public Administration*. He is an active member in the International Association of Administrative Sciences, holds adjunct professorship in a number of Chinese universities.

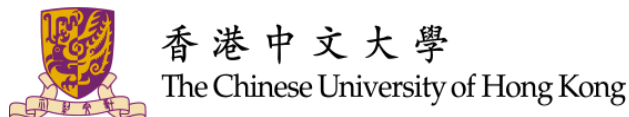
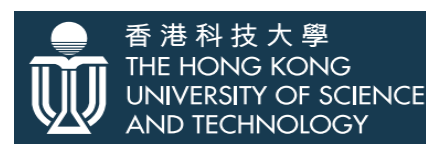
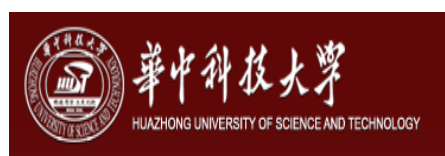
